bill, the Office of Policy and Legal Analysis and the Office of the Revisor of Statutes shall eliminate confusing language and
make technical changes necessary to improve the accessibility of all provisions pertaining to violence and threatening behavior in
schools. The recodification is not intended to contain substantive changes to Title 20-A.

Participation of department. The Office of Policy and
 Legal Analysis and the Office of the Revisor of Statutes shall invite the participation of the Department of Education in
 preparing the proposed recodification.

14 3. Report. The Office of Policy and Legal Analysis and the Office of the Revisor of Statutes shall submit the proposed bill
16 to the Joint Standing Committee on Education and Cultural Affairs no later than January 2, 2006.'

SUMMARY

22 This amendment replaces the bill with a resolve that directs the Office of Policy and Legal Analysis and the Office of the Revisor of Statutes to identify provisions in the Maine Revised Statutes, Title 20-A that pertain to violent and threatening behavior in schools and prepare a bill to make technical changes and reorganize these provisions for submission to the Second Regular Session of the 122nd Legislature.
