SUMMARY

12 The resolve creates the Task Force To Study and Design a Child Protection Mediation System. This amendment revises the language concerning the advisory member from the Judicial Branch by requiring that member to be from the District Court, which handles child protection cases, rather than the Supreme Judicial Court. This amendment amends the resolve to include the issue of sufficient court clerk support for matters involving children. This amendment also specifies the deadline for convening the task 20 force and clarifies the provision regarding staff assistance.

The projected costs to fund the general operating expenses of this study are \$3,840 in fiscal year 2005-06. The Legislature's budget includes \$30,000 in fiscal year 2005-06 and \$20,000 in fiscal year 2006-07 for legislative studies. Whether the amounts are sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature.
