COMMITTEE AMENDMENT "B" to H.P. 727, L.D. 1074, Bill, "An Act To Stimulate Economic Development in Maine's Aviation Industry"

Amend the bill in section 2 by striking out all of subsection 88 (page 1, lines 8 to 11 in L.D.) and inserting in its place the following:

'88. Aircraft and parts. Sales or leases of aircraft that weigh over 6,000 pounds, that are propelled by one or more turbine engines or that are in use by a Federal Aviation Administration classified 135 operator.'

SUMMARY

This amendment, which is a minority report of the committee, limits the exemption for aircraft to those that weigh over 6,000 pounds, that are propelled by turbine engines or are in use by a Federal Aviation Administration classified 135 operator and removes aircraft parts from the exemption.

### Fiscal Detail and Notes

Providing a sales and use tax exemption for certain aircraft sales and leases is expected to reduce General Fund revenue by \$572,437 in fiscal year 2005-06 and \$754,185 in fiscal year 2006-07 based on an October 1, 2005 effective date.
