24	Amend the bill by striking out everything after the enacting clause and before the summary and inserting in its place the following:

waters. Rules adopted to add a lake or pond to the list established under subsection 1 are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

3. Removal of waters from list. The commissioner may by rule remove a lake or pond from the list established in subsection 1. Rules adopted pursuant to this subsection are major substantive rules as defined in Title 5, chapter 375, subchapter 2-A.

4. Stocking native brook trout waters. The commissioner 12 may not stock or issue a permit to stock fish in a lake or pond listed as native brook trout water under this section. 14

5. Fishing restrictions. A person may not use live fish bait or possess live fish bait on a lake or pond listed as native brook trout water under this section. A person who violates this subsection commits a Class E crime.'

SUMMARY

This amendment replaces the bill and directs the Commissioner of Inland Fisheries and Wildlife to adopt by major 24 substantive rule a list of lakes and ponds identified as native brook trout waters that have never been stocked. It authorizes 26 the commissioner to add bodies of water to the initial list of native brook trout waters by routine technical rule if that body 28 of water meets criteria established by the commissioner. It also 30 provides that the commissioner may remove a lake or pond from the list by major substantive rule. This amendment provides that the commissioner may not stock or issue a permit to stock fish in 32 native brook trout water and makes the use or possession of live bait fish on such a lake or pond a Class E crime. Finally, the 34 amendment recognizes the eastern brook trout as a Maine heritage 36 fish.
