'Sec. 1. Initiative for prevention of suicide. Resolved: That the Commissioner of Health and Human Services shall establish a program for the prevention of adult suicide. The development of the program must include a working group consisting of personnel from the Department of Health and Human Services, Bureau of Elder and Adult Services and Bureau of Health and the department's office of adult mental health services. The working group must include the following persons appointed by the President of the representatives of advocacy groups for persons who are elderly and persons with mental illness, family members of adults who have completed suicide and other interested persons. Speaker of the House shall appoint a person representing the Joint Advisory Committee on Select Services for Older Persons and representatives of employers, providers of primary health care services and consumers of mental health services and such other persons as may be needed to develop an effective program. Members of the working group serve without pay or reimbursement for expenses. The program must be created within existing resources developed through applications for grant funding, donations and other means; and be it further'
