#### SUMMARY

This amendment, which is the minority report of the committee, replaces the bill. The amendment raises the limit on work hours for a 17-year-old while school is in session from 20 hours per week to 30 hours per week, if the 17-year-old provides proof to the employer of achievement of an overall B average for the prior semester. The amendment also raises the limit on work hours for 17-year-olds while school is in session from 4 hours per day to 6 hours per day. The amendment adds an appropriations and allocations section to the bill.


