Resolve, To Establish the Commission To Study the Licensing Conflicts between the Department of Agriculture, Food and Rural Resources and the Department of Health and Human Services

Sec. 1. Commission established. Resolved: That the Commission to Study the Licensing Conflicts between the Department of 2 Agriculture, Food and Rural Resources and the Department of Health and Human Services, referred to in this resolve as "the 4 commission," is established; and be it further б Sec. 2. Commission membership. Resolved: That the commission consists of 13 members appointed as follows: 8 10 1. Two members of the Senate, appointed by the President of the Senate; 12 Four members of the House of Representatives, appointed 2. 14 by the Speaker of the House of Representatives; 16 One member from the Department of Agriculture, Food and з. Rural Resources, appointed by the Governor; 18 4. One member from the Department of Health and Human 20 Services, appointed by the Governor; One member who is an owner or operator of a restaurant, 22 5. appointed by the President of the Senate; 24 6. One member who is an owner or operator of a convenience store, appointed by the President of the Senate; 26 One member who is an owner or operator of a lodging 28 7. establishment, appointed by the President of the Senate; 30 One member who is a food processor, appointed by the 8. 32 Speaker of the House of Representatives; and 34 One member who is a campground owner, appointed by the 9. Speaker of the House of Representatives; and be it further 36 Sec. 3. Chairs. Resolved: That the first-named Senate member is the Senate chair of the commission and the first-named House 38 of Representatives member is the House chair of the commission; and be it further 40 Sec. 4. Appointments; convening of commission. Resolved: 42 That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall 44 notify the Executive Director of the Legislative Council once all appointments have been completed. Within 15 days after 46 appointment of all members, the chairs shall call and convene the first meeting of the commission; and be it further 48

Sec. 5. Duties. Resolved: That the commission shall study the 2 licensing conflicts between the Department of Agriculture, Food 4 and Rural Resources and the Department of Health and Human Services in order to: 6 1. Identify the appropriate licensing agency for health-related licenses and inspections; 8 2. Eliminate duplicate licensing requirements; and 10 Establish a central location to obtain necessary 12 3. information for licensing procedures; and be it further 14 Sec. 6. Meetings. Resolved: That, in examining the issues, the commission shall meet 4 times to fulfill its duties; and be 16 it further 18 Sec. 7. Staff assistance. Resolved: That, upon approval of the Legislative Council, the Office of Policy and Legal Analysis 20 shall provide necessary staffing services to the commission; and be it further 22 Sec. 8. Compensation. Resolved: That the legislative members 24 of the commission are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 26 2, and reimbursement for travel and other necessary expenses related to their attendance at authorized meetings of the 2.8 commission. Public members not otherwise compensated by their 30 employers or other entities that they represent are entitled to receive reimbursement for necessary expenses and, upon а demonstration of financial hardship, a per diem equal to the 32 legislative per diem for their attendance at authorized meetings of the commission; and be it further 34 Sec. 9. Report. Resolved: That, no later than January 30, 36 2006, the commission shall submit a report that includes its 38 findings and recommendations, including suggested legislation, for presentation to the Second Regular Session of the 122nd commission is authorized 40 Legislature. The to introduce legislation related to its report to the Second Regular Session

of the 122nd Legislature at the time of submission of its report; 42 and be it further 44

Sec. 10. Extension. Resolved: That, if the commission requires a limited extension of time to complete its stady and make its 46 report, it may apply to the Legislative Council, which may grant an extension; and be it further 48

Sec. 11. Commission budget. Resolved: That the chairs of the 2 commission, with assistance from the commission staff, shall administer the commission's budget. Within 10 days after its first meeting, the commission shall present a work plan and 4 proposed budget to the Legislative Council for its approval. The commission may not incur expenses that would result in the б commission's exceeding its approved budget. Upon request from the commission, the Executive Director of the Legislative Council 8 shall promptly provide the commission chairs and staff with a status report on the commission budget, expenditures incurred and 10 paid and available funds. 12
