## An Act To Assist Families and Children by Increasing Access to the Court System

Emergency preamble. Whereas, acts of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 4 Whereas, the courts of the State have experienced a steady 6 increase in the number of matters involving families and children; and 8 Whereas, the very system designed to help them has stalled; 10 and 12 Whereas, delays have a detrimental effect on those whose cases cannot be reached; and 14 Whereas, it is vitally necessary that resources be made available to prevent any injustice or hardship to the citizens of 16 Maine: and 18 Whereas, in the judgment of the Legislature, these facts 20 create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 22 safety; now, therefore, 24 Be it enacted by the People of the State of Maine as follows: 26 Sec. 1. Appropriations and allocations. The following 28 appropriations and allocations are made.
