COMMITTEE AMENDMENT "A" to H.P. 942, L.D. 1359, Bill, "An Act To Amend the Maine Health Data Organization Statutes and To Extend the Operation of the Maine Health Data Processing Center"

Amend the bill by inserting after the title and before the enacting clause the following:

**'Emergency preamble. Whereas,** acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** the statute authorizing the Maine Health Data Processing Center will be repealed September 1, 2005 unless this bill takes effect prior to September 1, 2005; and

**Whereas,** in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'

Further amend the bill in section 1 in that part designated "**§691.**" in the first paragraph in the first line (page 1, line 8 in L.D.) by striking out the following: "2010" and inserting in its place the following: '2009'

Further amend the bill by striking out all of sections 6, 8 and 10.

Further amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

2 Further amend the bill by inserting at the end before the  
summary the following:

4 'Emergency clause. In view of the emergency cited in the  
6 preamble, this Act takes effect when approved.'

8 **SUMMARY**

10 This amendment removes from the bill the provisions that  
12 changed rules of the Maine Health Data Organization from major  
substantive to routine technical. It also changes the repeal  
14 date of the Maine Health Data Processing Center statute to  
September 1, 2009 and adds an emergency preamble and emergency  
clause.
