HOUSE AMENDMENT "**A**" to COMMITTEE AMENDMENT "A" to H.P. 955, L.D. 1369, "Resolve, Directing the Department of Administrative and Financial Services, Bureau of the Budget To Review Unfunded Mandates"

Amend the amendment by striking out the substitute title and replacing it with the following:

'Resolve, Directing the Intergovernmental Advisory Group to Review Unfunded Mandates'

Further amend the amendment in the emergency preamble in the 2nd paragraph in the first and 2nd lines (page 1, lines 37 and 38 in amendment) by striking out the following: "Executive Department, State Planning Office" and inserting in its place the following: 'Intergovernmental Advisory Group'

Further amend the amendment in section 1 by striking out all of the first indented paragraph (page 2, lines 1 to 8 in amendment) and inserting in its place the following:

'Sec. 1. Intergovernmental Advisory Group to conduct review. Resolved: That the Intergovernmental Advisory Group established in the Maine Revised Statutes, Title 5, section 12004-I, subsection 75-C shall conduct a review of unfunded state mandates that pertain to municipalities and shall identify those unfunded state mandates that were enacted prior to November 23, 1992, the effective date of the Constitution of Maine, Article IX, Section 21, which limits the imposition of unfunded state mandates. In conducting its review, the Intergovernmental Advisory Group shall:'

Further amend the amendment in section 2 in the 2nd line
(page 2, line 45 in amendment) by striking out the following:
"Executive Department, State Planning Office" and inserting in
its place the following: 'Intergovernmental Advisory Group'

Further amend the amendment in section 3 in the 2nd line
(page 3, line 5 in amendment) by striking out the following:
"Executive Department, State Planning Office" and inserting in
its place the following: 'Intergovernmental Advisory Group'

Further amend the amendment in section 3 in the 7th and 10th
lines (page 3, lines 10 and 13 in amendment) by striking out the
following: "State Planning Office" and inserting in their place
the following: 'Intergovernmental Advisory Group'

This amendment changes the agency responsible for the review
of unfunded state mandates from the Executive Department, State
Planning Office to the Intergovernmental Advisory Group.
