## An Act To Change the Membership of the Inland Fisheries and Wildlife Advisory Council

A, §2 and affected by c. 614, §9, is repealed. 14 Sec. 3. 12 MRSA §10151-A is enacted to read: 16 18 **<u>§10151-A.</u>** Inland Fisheries and Wildlife Advisory Council 20 The Inland Fisheries and Wildlife Advisory Council, as established by Title 5, section 12004-G, subsection 20 and referred to in this Part as "the advisory council," shall advise 22 the commissioner on matters pertaining to fisheries and wildlife. 24 1. Membership. The council consists of 11 members 26 appointed by the Governor as follows: A. One member representing a hunting organization; 28 30 B. One member representing a fishing organization; C. One member representing an alternative sportsman's 32 organization; 34 D. One member representing wildlife watchers; 36 E. One member representing the interests of hikers, canoers and kayakers; 38 F. One member representing the interests of professional 40 quides; 42 G. One member representing the interests of wildlife habitat conservation; 44 H. One member from a state animal protection organization; 46 I. One member from the Maine Warden Service; 48 J. One member representing the interests of trappers; and 50

sportsman. 4 2. State member; staff. The commissioner or the 6 commissioner's designee serves as an ex officio nonvoting member of the advisory council. The department shall provide necessary 8 staffing services to the advisory council. 10 3. Compensation. Members of the advisory council are entitled to travel and meal expenses only. 12 4. Terms of office. Except for the commissioner or the 14commissioner's designee, each member serves for a term of 3 years or until the member's successor has qualified. Except for the commissioner or the commissioner's designee, a member may not 16 serve more than 2 consecutive terms. In the case of a vacancy for 18 any reason, the Governor shall appoint a member representing the same interest to fill the unexpired term. 20 5. Administration; meetings. The advisory council shall elect one of its members as chair. The chair serves for a 2-year 22 period and may not serve as chair for consecutive 2-year periods. 24 The advisory council shall hold regular public meetings every 26 other month but may waive by majority vote a succeeding meeting. The chair shall call special meetings of the advisory council 28 whenever requested in writing by 2 or more members. The advisory council shall send notice and minutes of the meetings to the 30 joint standing committee of the Legislature having jurisdiction over animal welfare matters. 32 6. Duties. The advisory council shall: 34 A. Review and advise the commissioner on proposed revisions to wildlife laws and rules; 36 38 B. Assist the commissioner in the continuing implementation and evaluation of the wildlife laws and rules; 40 C. Maintain communication with the public; 42 D. Establish long-range goals and objectives pertaining to 44 the interest of the State's wildlife; 46 E. Research options for increasing revenue to the Department of Inland Fisheries and Wildlife; and 48

K. One member representing the public who is not a

F. Advise the commissioner on other matters related to wildlife issues, laws and rules.

Sec. 4. Transition; members. Members of the Inland Fisheries and Wildlife Advisory Council in office on the effective date of this Act continue in office for the remainder of their terms. When the term of office of a member expires, that member's successor is appointed pursuant to the Maine Revised Statutes, Title 12, section 10151-A, subsection 1.
