40	SUMMARY
42	This bill amends the law regarding the certification of educational personnel in 3 ways.
44	1. It authorizes the granting of a certificate or
46	authorization of personnel who provide early childhood education programs or developmental therapy to all children from birth to
48	age 5. Currently, the certificate or authorization is limited to educational personnel who provide programs or developmental
50	therapy to children birth to school age 5 who have disabilities.

 It repeals the requirement for certification that all educational personnel have knowledge of physiology and hygiene
and the effects of alcohol, stimulants and narcotics upon the human system.

3. It revises the conditional certificate for
administrators to allow the Department of Education to grant a
maximum of 2 one-year conditional administrator certificates.
Currently, conditional administrator certificates can be granted
for only one year.
