Fiscal Detail and Notes

Included in this legislation is a General Fund appropriation of \$12,000 annually to the Legislature to provide funds for Legislative Youth Advisory Council activities. This bill also requires the Legislative Council to provide staff assistance and authorizes the Legislative Council to seek outside sources of funding for the costs of the advisory council, which may result in the collection of Other Special Revenue funds. A base allocation of \$500 in each of fiscal years 2005-06 and 2006-07 is included in the event outside sources of funding are received.
