SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 1077, L.D. 1532

Further amend the amendment in section 2 in that part 2 designated "**§1328.**" in subsection 2 by striking out all of paragraph B (page 3, lines 48 and 49 in amendment) and inserting 4 in its place the following:

'<u>B. The form must also include all the provisions required</u> by federal law.'

Further amend the amendment in section 2 in that part designated "**§1328.**" in subsection 2 in paragraph C in the last line (page 4, line 7 in amendment) by inserting after the following: "rights." the following: 'This acknowledgement does not affect rights, duties or liability under federal law.'

Further amend the amendment in section 2 in that part 16 designated "**§1328.**" in subsection 2 by striking out all of paragraph D (page 4, lines 9 and 10 in amendment)

Further amend the amendment in section 2 in that part 20 designated "**§1328.**" by inserting after subsection 3 the following:

22 '<u>4. Rights, duties or liability under federal law. This section may not be construed to affect rights, duties or liability under federal law.</u>'

## **SUMMARY**

This amendment clarifies that the Department of Health and Human Services may combine the new form requirements and the federal form requirements into one form for sellers and another form for lessors. The amendment also adds a statement that the disclosure forms provisions are not to be construed to affect any rights, duties or liability under federal law.
