24 Act To Repeal Certain Boards and Commissions"

26 Amend the bill by striking out all of sections 1 to 7, 10,  
28 11, 13, 16, 19, 20 and 21.

30 Further amend the bill by striking out all of section 24 and  
32 inserting in its place the following:

34 'Sec. 24. 5 MRSA §12004-I, sub-§52-B, as enacted by PL 1995,  
36 c. 694, Pt. A, §1, is repealed.'

38 Further amend the bill by striking out all of sections 26 to  
40 28, 30, 32, 33, 36 to 38, 44 to 48, 50 to 54, 62 and 64.

42 Further amend the bill by striking out all of sections 65  
44 and 66 and inserting in their place the following:

46 'Sec. 65. 36 MRSA §7104, as amended by PL 2003, c. 643, §8,  
48 is repealed.'

Further amend the bill by relettering or renumbering any  
nonconsecutive Part letter or section number to read  
consecutively.

Maine-Canadian Legislative Advisory Commission; New England and Eastern Canada Legislative Commission; Commission on Performance Budgeting; Nutrient Management Review Board; Potato Marketing Improvement Committee; Natural Areas Advisory Board; Policy Review Council; State Conservation District Advisory Council; Participating Local District Advisory Committee, State Retirement Program; and the Maine-New Hampshire Interstate Bridge Authority. The amendment also adds a section that removes obsolete language that refers to the Maine Revised Statutes, Title 19 that no longer exists. It also repeals the Multistate Tax Compact Advisory Committee, rather than the entire Multistate Tax Compact chapter in Title 36.
