COMMITTEE AMENDMENT "A" to H.P. 1133, L.D. 1606, Bill, "An Act To Sunset Income Tax Checkoffs"

Amend the bill by striking out the title and substituting the following:

'An Act To Sunset the Income Tax Checkoff for Qualified Political Parties'

Further amend the bill by striking out all of sections 1 to 6.

Further amend the bill by striking out all of sections 8 to 14 and inserting in their place the following:

'Sec. 8. Application. This Act applies to tax years beginning on or after January 1, 2006.'

Sec. 9. Appropriations and allocations. The following appropriations and allocations are made.
