9 COMMITTEE AMENDMENT "A" to H.P. 1219, L.D. 1712, Bill, "An Act To
10 Restore the Funding to the Fund for the Efficient Delivery of Local and Regional
11 Services"

12 Amend the bill by striking out everything after the title and before the summary and
13 inserting in its place the following:

14 **'Be it enacted by the People of the State of Maine as follows:**

15 **Sec. 1. PL 2005, c. 457, Pt. EE, §1** is amended to read:

16 **Sec. EE-1. Transfer from Fund for Efficient Delivery of Local and**
17 **Regional Services.** Notwithstanding the Maine Revised Statutes, Title 30-A, section
18 5681, subsection 5-B or any other provision of law, the State Controller shall transfer
19 \$2,335,918 from the Fund for the Efficient Delivery of Local and Regional Services to
20 the unappropriated surplus of the General Fund no later than June 30, 2006 ~~and transfer~~
21 ~~\$2,451,935 from the Fund for the Efficient Delivery of Local and Regional Services to~~
22 ~~the unappropriated surplus of the General Fund no later than June 30, 2007.'~~

23 **SUMMARY**

24 This amendment replaces the bill. It restores the 2nd year of funding for the Fund for
25 the Efficient Delivery of Local and Regional Services by amending the section of Public
26 Law 2005, chapter 457 that would have transferred the money to the General Fund by
27 June 30, 2007. The amendment also strikes the emergency preamble and emergency
28 clause.
