An Act To Establish the Athens Standard Water District

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. Territorial limits; corporate name.** Pursuant to the Maine Revised
3 Statutes, Title 35-A, chapter 64, that part of the Town of Athens described as follows and
4 its inhabitants constitute a standard district under the name Athens Standard Water
5 District, referred to in this Act as "the district":

6 Beginning at the point of intersection of the eastern bank of the Wesserunsett Stream and
7 the southern shoulder of Route 150; thence south to the southwestern corner of Lot 74,
8 Map 15, property maps, Town of Athens; thence easterly along the southern border of Lot
9 74; thence easterly across East Ridge Road; thence southerly along the east side of East
10 Ridge Road, approximately 100 feet; thence easterly along the southern border of Lot 71,
11 Map 15; thence easterly to the intersection of the southeast corner of Lot 71, Map 15 and
12 Route 43; thence easterly across Route 43 to a point of intersection of the east side of
13 Route 43 and Lot 70, Map 15; thence southeasterly along Route 43 to the southwest
14 corner of Lot 5, Map 3; thence northeasterly along Lot 5, Map 3; thence north along the
15 eastern border of Lot 5, Map 3; thence due north to the intersection of Fox Hill Road;
16 thence due north across Fox Hill Road to the northerly side of Fox Hill Road; thence
17 easterly along the north side of Fox Hill Road to the southeast corner of Lot 59, Map 15;
18 thence northerly along the eastern border of Lots 59, 58, 56, the cemetery lot and Lot 28,
19 to the intersection of the northeast corner of Lot 28 and Route 150; thence north across
20 Route 150 to the northerly side of Route 150; thence southwesterly along Route 150 to
21 the eastern border of Lot 9, Map 7; thence northerly along the eastern border of Lot 9,
22 Map 7 to the southern bank of the east branch of the Wesserunsett Stream; thence
23 southwesterly along the east bank of said stream to Route 151; thence across Route 151;
24 thence westerly along the south bank of said stream to the east side of the Wesserunsett
25 Stream; thence southerly along the east bank of said stream to the southernmost corner of
26 Lot 16-11, Map 2; thence across said stream to the west bank of said stream; thence
27 northerly along the west bank of said stream to the northernmost point of Lot 12, Map 15;
28 thence southerly along the western boundary of Lot 12, Map 15 to the intersection of the
29 northern boundary of Lot 9, Map 15; thence westerly and southerly along the western
30 border of Lot 9, Map 15 to the Eaton Corner Road; thence across the Eaton Corner Road
31 to the southern edge of the Eaton Corner Road; thence easterly along the southern edge of
32 the Eaton Corner Road to the point of beginning.

33 **Sec. 2. Powers; authority; duties.** The district has all the powers and authority
34 and is subject to all the requirements and restrictions provided in the Maine Revised
35 Statutes, Title 35-A, chapter 64.

36 **Sec. 3. Power to take water.** For purposes of its incorporation, the district is
37 authorized to take water from any source in the Town of Athens.

38 **Sec. 4. Number of trustees.** The board of trustees of the district is composed of 3
39 trustees. A trustee must be a resident of the district and reside in a household to which
40 the district's service is provided.

41 **Sec. 5. Election of first board.** The first board is elected in an election called by
42 the municipal officers of the Town of Athens by the voters in accordance with this Act.
43 The terms of the first board are governed by the Maine Revised Statutes, Title 35-A,
44 section 6410.
