Fiscal Detail and Notes

This bill expands the number of people who would be eligible for tuition waivers at a state postsecondary educational institute. Because this legislation does not change the maximum number of new tuition waivers that may be granted each year pursuant to 20-A MRSA §12573 sub-§3, the potential fiscal liability to the University of Maine System, the Maine Community College System and Maine Maritime Academy remains unchanged.

However, expanding eligibility for tuition waivers will increase the actual costs incurred by the higher educational institutions because they are below the cap for such waivers. For example, the maximum number of tuition waivers that may be granted by the University of Maine System during one year is 140 waivers (28 waivers each year for no more than 5 years.) The actual number of waivers granted by the University in FY 2002-03 was 27 and 29 waivers were awarded FY 2003-04. In FY 2004-05, 43 waivers were granted at a cost of \$150,000. The University estimates the total cost if all 140 waivers were granted would be between \$500,000 and \$700,000, or approximately \$350,000 - \$550,000 more than the FY05 costs.

Current law requires that state postsecondary educational institutions absorb the reduction in tuition revenues and not request a General Fund appropriation to fund the cost of the tuition waivers. Given the current budgetary constraints, the ability of the University of Maine System and the Maine Community College System to absorb the additional costs without impacting other programs or services currently in place can not be determined.
