#### Fiscal Detail and Notes

The bill includes an appropriation of \$118,000 to the Department of Health and Human Services for costs resulting from doubling fees paid to sheriffs, deputies and authorized persons for service of writs and complaints on behalf of the State. Of this total appropriation, \$50,000 is estimated to be needed for the Office of Child and Family Services and \$68,000 for the Division of Support Enforcement and Recovery in the Office of Integrated Access and Support.
