1. Photograph. A lobbyist or lobbyist associate shall ensure that the commission has a recent photograph of the 4 lobbyist or lobbyist associate. 6 2. Lobbyist or lobbyist associate information. The 8 commission shall determine other information that may be provided by a lobbyist or lobbyist associate for inclusion in the registration docket and on the disclosure website provided in 10 section 315-A. SUMMARY

This amendment removes the changes to the definition of 4 "lobbying" as proposed in Committee Amendment "A" and removes references to "issue" as it pertains to lobbying.

This amendment also requires each lobbyist and lobbyist associate, including state agency employees, to provide a recent photograph, and requires the Commission on Governmental Ethics and Election Practices to determine other information that a lobbyist or lobbyist associate may provide for inclusion in the registration docket and on the disclosure website.
