Name tag required 26 A person who is required to register as a lobbyist under section 313 or, notwithstanding section 313-A, under section 28 313-A shall wear on that person's outer garment a clearly visible name tag when lobbying in the State House complex. This name tag 30 must have white lettering on a hunter orange background and must 32 be at least 1 1/2 inches high and 2 1/2 long. This name tag must consist of the lobbyist's first and last name and the word 34 "lobbyist" or the name of the organization represented in letters at least 1/4 inch high.' 36 SUMMARY 38 40 This amendment, modelled on New Hampshire law, requires a registered lobbyist to wear a name tag when lobbying in the State

Requiring that lobbyists must wear a specific identifying tag will result in minor additional costs to those various state agencies that have employees who are registered as lobbyists. The affected agencies can provide the required tags within existing budgeted resources.
