An Act To Amend the Elementary School Closing Process for School Administrative Districts and Community School Districts

" \$ 36 **SUMMARY** 38 40 This bill eliminates the requirement for a referendum vote in a member municipality of a school administrative district or 42 community school district where the school board has voted to close an elementary school. A referendum vote could still be triggered by a petition signed by 10% of the number of voters in 44 the affected municipality who voted in the last gubernatorial 46 election. 48
