

### **Fiscal Detail and Notes**

This fiscal note reflects the incremental difference between the amendment and the majority report. It assumes a \$200,000 reduction in Dirigo Health Agency personal services costs to be achieved by eliminating up to 3 Dirigo Health Agency positions or cutting Dirigo Health Agency payroll across the board, and includes a fiscal year 2006-07 Other Special Revenue Funds deallocation for this purpose.
