1 Emergency preamble. Whereas, acts of the Legislature do not become effective 2 until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, this legislation needs to take effect before the expiration of the 90-day 4 period in order to provide assistance in purchasing home heating fuel to residents during 5 the current heating season; and 6 Whereas, in the judgment of the Legislature, these facts create an emergency within 7 the meaning of the Constitution of Maine and require the following legislation as 8 immediately necessary for the preservation of the public peace, health and safety; now, 9 therefore, 10 Be it enacted by the People of the State of Maine as follows: 11 Sec. 1. Appropriations and allocations. The following appropriations and 12 allocations are made.
