### Fiscal Detail and Notes

This amendment will increase the General Fund cost of the bill by \$96,000 in fiscal year 2005-06 and \$96,000 in fiscal year 2006-07. Based on the estimated year-end balances, this amendment maintains a balanced budget for the 2006-2007 biennium.
