HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "B" to H.P. 1382, L.D. 1974, Bill, "An Act To Make Additional Allocations from the Highway Fund and Other Funds for the Expenditures of State Government and To Change Certain Provisions of State Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2005 and June 30, 2006"

Amend the amendment by adding after Part P the following:

PART Q

Sec. Q-1. 25 MRSA §1509 is enacted to read:

§1509. Funding

Beginning in fiscal year 2007-08, state funding for the Department of Public Safety, Bureau of State Police must be provided as follows:

1. Highway Fund. Sixty percent must be allocated from the Highway Fund pursuant to Title 23, section 1653; and

2. General Fund. Forty percent must be appropriated from the General Fund.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

Future biennium cost increase - General Fund

Fiscal Note

The requirement that 60% of the future funding for the State Police program must come from the Highway Fund and 40% from the General Fund beginning in fiscal year 2007-08 will mean a cost increase for the General Fund and an equivalent savings for the Highway Fund. In comparison, the currently budgeted ratio for fiscal year 2006-07 is approximately 65% Highway and 35% General Fund.
