9 COMMITTEE AMENDMENT "A" to H.P. 1444, L.D. 2050, Resolve, "Resolve, To
10 Allow the Department of Inland Fisheries and Wildlife To Convey a Part of a Parcel of
11 Land in the Town of Fairfield"

12 Amend the resolve by inserting after the title and before section 1 the following:

13 **Preamble.** The Constitution of Maine, Article IX, Section 23 requires that real
14 estate held by the State for conservation or recreation purposes may not be reduced or its
15 uses substantially altered except on the vote of 2/3 of all members elected to each House.

16 **Whereas,** certain real estate authorized for conveyance by this resolve is under the
17 designations described in the Maine Revised Statutes, Title 12, section 598-A; and

18 **Whereas,** the Commissioner of Inland Fisheries and Wildlife may sell or exchange
19 lands with the approval of the Legislature in accordance with the Maine Revised Statutes,
20 Title 12, sections 10109 and 12708; now, therefore, be it '

21 Further amend the resolve in section 1 in the 4th line (page 1, line 4 in L.D.) by
22 inserting after the following: "convey for" the following: 'the appraised fair market value
23 and for'

24 **SUMMARY**

25 This amendment adds a preamble to the resolve and provides that the land may be
26 sold for the appraised fair market value.
