WHEREAS, the Legislature has learned with deep regret of the death of:

(4-3) Charles E. Everett, who was born and lived most of his life of 93 years in Presque Isle. Mr. Everett graduated from Aroostook State Normal School and was a graduate of the Boston School of Anatomy and Embalming. For many years he was employed as the manager of the parts department at Maine Potato Growers. He began his career at the International Harvester Company. During the 1940s, Mr. Everett owned a country store at State Road Siding and then returned to the farm machinery business. He was an avid golfer and a member of the Presque Isle Country Club. He was also a former member of the Abnaki Club and the Presque Isle Kiwanis Club and a past master of the Masonic Lodge in Mars Hill. He loved music and belonged to the Presque Isle chapter of the Society for the Preservation and Encouragement of Barbershop Quartet Singing in America and also sang bass as a member of The Roadrunners, a barbershop quartet that sang throughout Maine and New Brunswick, Canada.
