Amend the amendment by inserting after section 1 the following:

'Sec. 2. Transfer; Carrying Balances, General Fund account.

13

Notwithstanding any other provisions of law, no later than September 15, 2007, the State
14 Controller shall transfer \$41,216 from the Carrying Balances, General Fund account
15 within the Department of Inland Fisheries and Wildlife to the unappropriated surplus of
16 the General Fund, and no later than September 15, 2008 the State Controller shall transfer
17 \$41,216 from the Carrying Balances, General Fund account within the Department of
18 Inland Fisheries and Wildlife to the unappropriated surplus of the General Fund.'


