13	'Sec. 1. 12 MRSA §11224 is enacted to read:				
14	<u>§11224. Alien big game hunter; guide required</u>				
15 16 17	An alien may not hunt moose, deer or bear without being accompanied by a person who holds a valid guide license pursuant to chapter 927 authorizing that person to act as a hunting guide.				
18 19	<b>1.</b> Civil violation. A person who violates this section commits a civil violation for which a fine of not less than \$100 nor more than \$500 may be adjudged.				
20 21 22	<b>2.</b> Class E crime. A person who violates this section after having been adjudicated as having committed 3 or more civil violations under this Part within the previous 5-year period commits a Class E crime.'				
23	SUMMARY				
24 25 26 27	This amendment replaces the bill and is similar in requiring a person who is not a citizen of the United States to be accompanied by a licensed guide but specifically applies to hunting moose, deer or bear. The amendment also provides penalties for violations of the provision.

#### **Fiscal Detail and Notes**

Beginning in fiscal year 2007-08, requiring that all alien big game hunters must be accompanied by a registered Maine Guide will result in the estimated annual loss of \$41,216 in General Fund revenue from fewer Alien Big Game hunting licenses being sold.
