9 COMMITTEE AMENDMENT "A" to H.P. 142, L.D. 160, Bill, "An Act To Provide 10 Safe All-terrain Vehicle Access on Public Ways"

11 Amend the bill by striking out everything after the enacting clause and before the 12 summary and inserting the following:

'Sec. 1. 12 MRSA §13157-A, sub-§6, ¶H, as enacted by PL 2003, c. 655, Pt. B,
§414 and as affected by §422, is amended to read:

15 Notwithstanding paragraphs A to G, an ATV may be operated on the extreme H. right of a public way or as directed by the appropriate governmental unit within the 16 public way of a municipality or an unorganized or unincorporated township if the 17 appropriate governmental unit has designated the public way as an ATV-access route. 18 An ATV must travel in the same direction as motor vehicle traffic on a public way 19 20 designated as an ATV-access route. A public way designated by an appropriate governmental unit as an ATV-access route must be posted conspicuously at regular 21 22 intervals by that governmental unit with highly visible signs designating the ATV-Before designating a public way as an ATV-access route, the 23 access route. appropriate governmental unit shall make appropriate determinations that ATV travel 24 25 on the extreme right of the public way or as directed by the appropriate governmental unit within the public way may be conducted safely and will not interfere with 26 27 vehicular traffic on the public way. For purposes of this paragraph, "appropriate governmental unit" means the Department of Transportation, county commissioners 28 29 or municipal officers within their respective jurisdictions. The jurisdiction of each 30 appropriate governmental unit over public ways pursuant to this paragraph is the 31 same as its jurisdiction over the passage of vehicles on public ways pursuant to Title 32 Municipal or county law enforcement officials having 29-A, section 2395. 33 jurisdiction have primary enforcement authority over any route established under this 34 paragraph.'

#### SUMMARY

2 The amendment gives municipalities, in addition to the Department of 3 Transportation, more flexibility in determining how and where ATV access occurs. The 4 amendment also requires that ATVs travel in the same direction as motor vehicle traffic 5 on a public way designated as an ATV-access route.
