### **An Act To Allow Military Personnel Stationed in Maine To Register All-terrain Vehicles As Residents**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §13155, sub-§11** is enacted to read:

3 **11. Member of United States Armed Forces permanently stationed in State.** A  
4 person may register in this State an ATV owned by that person pursuant to subsection 3  
5 at the resident fee specified in subsection 5 if that person is:

6 A. A person serving in the Armed Forces of the United States who is permanently  
7 stationed at a military or naval post, station or base in the State; or

8 B. The spouse or child of a person under paragraph A if the spouse or child  
9 permanently resides with that person.

10 A member of the Armed Forces of the United States stationed in the State or the spouse  
11 or child of that member who desires to register an ATV in this State shall present  
12 certification from the commander of the member's military or naval post, station or base,  
13 or from the commander's designated agent, that the member is permanently stationed at  
14 that post, station or base. The fee for registration of an ATV pursuant to this subsection  
15 must be allocated as if the person registering the ATV were a resident of the municipality  
16 in which the post, station or base is located.

17 **SUMMARY**

18 This bill allows a member of the Armed Forces of the United States who is  
19 permanently stationed at a military or naval post, station or base in Maine or the spouse  
20 or child of that member to register an ATV in Maine at the cost of a resident registration.  
21 The registration fees attributable to such a registration are allocated to the municipality in  
22 which the military or naval post, station or base is located.
