6 Initiative: Provides one-time funds to retire the mortgage of York County Community

## SUMMARY

2        This bill makes a one-time General Fund appropriation of \$3,710,633 in fiscal year  
3 2007-08 for the Maine Community College System to retire the mortgage of the York  
4 County Community College. This bill also deappropriates \$400,000 of the \$1,600,000 in  
5 ongoing General Fund appropriations provided in Private and Special Law 2005, chapter  
6 69 to the Maine Community College System beginning in fiscal year 2006-07 for general  
7 operating expenses. These funds were provided to cover the mortgage fee that would  
8 otherwise be paid by York County Community College students and will no longer be  
9 needed once the mortgage is retired.
