The Department of Corrections will require a General Fund appropriation of \$18,920 in fiscal year 2010-11 and \$56,865 in fiscal year 2011-12 and annually thereafter to provide funds for the incremental costs associated with one projected conviction per year beginning in fiscal year 2008-09.
