1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 9-A MRSA §3-315** is enacted to read:

3 **§3-315. Real estate settlement procedures**

4 A creditor shall comply with the provisions of the federal Real Estate Settlement  
5 Procedures Act of 1974, 12 United States Code, Section 2601 et seq. and its  
6 implementing regulation, Regulation X, 24 Code of Federal Regulations, Section 3500 et  
7 seq.

8 **Sec. 2. 9-A MRSA §9-311** is enacted to read:

9 **§9-311. Real estate settlement procedures**

10 A creditor shall comply with the provisions of the federal Real Estate Settlement  
11 Procedures Act of 1974, 12 United States Code, Section 2601, et seq. and its  
12 implementing regulation, Regulation X, 24 Code of Federal Regulations, Section 3500 et.  
13 seq.

14 **Sec. 3. 9-A MRSA §10-307** is enacted to read:

15 **§10-307. Real estate settlement procedures**

16 A loan broker shall comply with the provisions of the federal Real Estate Settlement  
17 Procedures Act of 1974, 12 United States Code, Section 2601 et seq. and its  
18 implementing regulation, Regulation X, 24 Code of Federal Regulations, Section 3500 et  
19 seq.

20 **SUMMARY**

21 This bill incorporates the federal Real Estate Settlement Procedures Act of 1974 and  
22 its implementing regulation into state law.
