Amend the bill in section 1 in §4350-A in the first paragraph in the first line (page 1, line 5 in L.D.) by striking out the following: "2016" and inserting in its place the following: '2012'

Amend the bill by adding at the end before the summary the following:

**'Sec. 2. Appropriations and allocations.** The following appropriations and allocations are made.

#### Fiscal Detail and Notes

The Community Preservation Advisory Committee will sunset on June 1, 2008 and is funded through that date. This bill extends the sunset until 2012 and includes a General Fund appropriation to the Legislature of \$3,270 annually beginning in fiscal year 2008-09. The appropriation will provide funds for the per diem and expenses of the six legislative members of the Committee.
