# COMMITTEE AMENDMENT "A" to H.P. 307, L.D. 391

1 **Sec. 5. Duties. Resolved:** That the task force shall conduct a review of adoption 2 laws and practices and propose a comprehensive public policy addressing the issues 3 involved in adoption laws and practices.

- 4 1. The task force shall:
- 5 A. Identify laws that relate to adoption;
- 6 B. Identify court jurisdiction over adoption-related issues;
- 7 C. Review paternity issues;

8 D. Consider appropriate accessibility to birth and family information, consistent with 9 existing and proposed federal requirements and identity theft concerns;

- 10 E. Determine the relation of the "safe haven" law to adoption issues;
- 11 F. Identify all interests affected by adoption laws and practices;
- 12 G. Review trends in other states concerning adoption laws and practices;
- 13 H. Propose an adoption public policy blueprint; and
- 14 I. Draft a comprehensive revision of all adoption laws consistent with the adoption 15 public policy blueprint.
- 16 2. The task force may:

A. Establish a non-voting advisory stakeholders group to help identify interests and
issues that should be included in the discussion and to help formulate the public
policy blueprint and the comprehensive revision of adoption laws consistent with the
blueprint;

- B. Hold informational sessions and discussions with experts, interested parties and
   practitioners; and
- 23 C. Hold a public hearing in Augusta; and be it further'
- Amend the resolve by striking out all of sections 7 to 10 and inserting the following:

25 'Sec. 7. Report. Resolved: That, no later than December 5, 2007, the task force 26 shall submit a report that includes its findings and recommendations, including suggested 27 legislation, to the Joint Standing Committee on Judiciary. Pursuant to Joint Rule 353, the 28 task force is not authorized to introduce legislation. Upon receipt of the report required 29 by this section, the Joint Standing Committee on Judiciary may, pursuant to Joint Rule 30 353, introduce a bill during the Second Regular Session of the 123rd Legislature to 31 implement its recommendations on matters relating to the study.'

## SUMMARY

This amendment revises the membership of the task force to consist of a total of 13 members: 3 Legislators, 2 members representing adoptees, 2 members representing birth parents, 2 members representing adoptive parents, 2 members representing adoption agencies, one member representing sexual assault victims' services providers and one member representing Probate Courts and probate registers. This task force may establish

#### Legislative Cost/Study

The general operating expenses of this Adoption Laws and Practices Task Force are projected to be \$6,330 in fiscal year 2007-08. The Legislature's proposed budget includes \$30,000 in fiscal year 2007-08 for legislative studies. Whether the amount is sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature.
