**'Sec. XXXX-47. Appropriations and allocations.** The following appropriations and allocations are made.

**ADMINISTRATIVE AND FINANCIAL SERVICES, DEPARTMENT OF  
Miscellaneous Acts and Resolves - Finance 0306**

Initiative: Provides one-time funds to the Kittery School District to offset a portion of the lower-than-expected state subsidy for fiscal year 2007-08 due to the downward reprojction in General Fund revenues.
