SENATE AMENDMENT “N” to COMMITTEE AMENDMENT “A” to H.P. 383,
9 L.D. 499, Bill, “An Act Making Unified Appropriations and Allocations for the
10 Expenditures of State Government, General Fund and Other Funds, and Changing Certain
11 Provisions of the Law Necessary to the Proper Operations of State Government for the
12 Fiscal Years Ending June 30, 2008 and June 30, 2009”

Amend the amendment in Part XXXX in section 13 in section §1451 in the 2nd
14 indented paragraph in the last line (page 752, line 5 in amendment) by inserting after the
15 following: “citizenship.” the following: ‘Regional school units are not required to operate
16 secondary school facilities. A regional school unit that does not operate a secondary
17 school facility may enter into a contract for the education of its secondary school students
18 pursuant to section 1479, subsection 2.’

19

Amend the amendment in Part XXXX in section 13 in section §1479 in the first
20 indented paragraph in the last line (page 769, line 36 in amendment) by striking out the
21 following: “12.” and inserting the following: ‘12, except that a regional school unit is not
22 required to operate a secondary school facility. A regional school unit that does not
23 operate a secondary school facility may enter into a contract for the education of its
24 secondary school students pursuant to subsection 2.’

Amend the amendment by relettering or renumbering any nonconsecutive Part letter
26 or section number to read consecutively.
