SUMMARY

7 This bill allocates funds from the Highway Fund for the Department of 8 Transportation to study the feasibility of locating a new bridge in the St. David area and 9 specifies that any unspent funds not needed for the costs of the study are to be used for 10 the costs of an environmental impact study required by the federal National 11 Environmental Policy Act of 1969. The bill also allocates funds to the Madawaska Bridge 12 Committee to defray expenses incurred by the committee in its effort to locate a new 13 bridge in the St. David area.
