1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §13071-A, sub-§4, ¶A,** as enacted by PL 2003, c. 655, Pt. B,
3 §384 and affected by §422, is amended to read:

4 A. A person may not operate a personal watercraft on:

5 (1) Mud Pond, Oversett Pond, South Pond, Round Pond, Twitchell Pond, Hicks
6 Pond, Indian Pond or Furlong Pond in the Town of Greenwood in Oxford
7 County;

8 (2) North Pond or Bryant Pond, also known as Christopher Lake, in the Town of
9 Greenwood and the Town of Woodstock in Oxford County;

10 (3) Concord Pond, Little Concord Pond or Shagg Pond in the Town of
11 Woodstock in Oxford County;

12 (4) Hamilton Pond in Bar Harbor in Hancock County;

13 (5) Bog Lake or Horseshoe Lake in the Town of Northfield in Washington
14 County;

15 (6) Megunticook Lake in the Town of Camden and the Town of Hope in Knox
16 County and the Town of Lincolnville in Waldo County;

17 (7) Hobbs Pond, Fish Pond or Alford Lake in the Town of Hope in Knox
18 County;

19 (8) Norton Pond or Coleman Pond in the Town of Lincolnville in Waldo
20 County;

21 (9) Pitcher Pond in the Town of Lincolnville and the Town of Northport in
22 Waldo County;

23 (10) Torsey Lake in the Town of Mount Vernon and the Town of Readfield in
24 Kennebec County;

25 (11) Trickey Pond in the Town of Naples in Cumberland County;

26 (12) Brandy Pond in the Town of Naples in Cumberland County between sunset
27 and 9:00 a.m.;

28 (13) Fulton Lake in the Town of Northfield in Washington County;

29 (14) Knight Pond in the Town of Northport in Waldo County;

30 (15) Moose Pond or Saturday Pond in the Town of Otisfield in Oxford County;

31 (16) Tripp Pond, Upper Range Pond or Middle Range Pond in the Town of
32 Poland in Androscoggin County;

33 (17) Keewaydin Lake, Virginia Lake, Trout Pond, Weymouth Pond or Whitney
34 Pond in the Town of Stoneham in Oxford County;

35 (18) Lermond Pond in the Town of Union and the Town of Hope in Knox
36 County;

- 1 (19) Pocasset Lake or Pickerel Pond in the Town of Wayne in Kennebec
2 County;
- 3 (20) Androscoggin Lake in the Town of Wayne in Kennebec County and the
4 Town of Leeds in Androscoggin County;
- 5 (21) Little Cobbosseecontee Lake in the Town of Winthrop in Kennebec
6 County;
- 7 (22) Somes Pond in the Town of Mount Desert;
- 8 (23) Long Pond in the Town of Mount Desert and the Town of Southwest
9 Harbor;
- 10 (24) Little Long Pond in the Town of Mount Desert;
- 11 (25) Meetinghouse Pond, Big Pond, Wat Tuh Lake, Center Pond and Silver
12 Lake, also known as Silver Pond, in the Town of Phippsburg in Sagadahoc
13 County;
- 14 (26) South Branch Lake in the Plantation of Seboeis and the Township of T2 R8
15 NWP in Penobscot County;
- 16 (27) Spring Lake in Spring Lake Township in Somerset County;
- 17 (28) Kennebago Lake and Kennebago River in Davis Township and
18 Stetsontown Township in Franklin County;
- 19 (29) Nicatous Lake in the Townships of T40 MD, T41 MD and T3 ND in
20 Hancock County;
- 21 (30) Crystal Lake in the Town of Washington in Knox County;
- 22 (31) Middle Branch Pond in the Town of Waterboro in York County;
- 23 (32) Highland Lake or Woods Pond in the Town of Bridgton in Cumberland
24 County if the personal watercraft is rented and does not display a decal
25 identifying the rental agency that owns the personal watercraft; ~~or~~
- 26 (33) Lake St. George in the Town of Liberty; or
- 27 (34) East Carry Pond, Middle Carry Pond and West Carry Pond in Carrying
28 Place Township, T2 R3 BKP WKR in Somerset County.

29 **SUMMARY**

30 This bill prohibits the operation of personal watercraft on East Carry Pond, Middle
31 Carry Pond and West Carry Pond in Carrying Place Township, T2 R3 BKP WKR in
32 Somerset County.
