COMMITTEE AMENDMENT "A" to H.P. 429, L.D. 551, Bill, "An Act To Create the Maine Health Card Program"

Amend the bill in section 1 in §3194 in subsection 2 in the 4th line (page 1, line 19 in L.D.) by striking out the following: "health" and inserting the following: 'program'

Amend the bill by inserting after section 1 the following:

**'Sec. 2. Appropriations and allocations.** The following appropriations and allocations are made.

#### Fiscal Detail and Notes

It is assumed any additional personal services needs and costs can be absorbed utilizing existing resources.
