12	'2. Person. "Person" means any individual, partnership, corporation or association.'
13 14	Amend the bill in section 1 in §1157 by renumbering the subsections to read consecutively.
15 16	Amend the bill in section 1 in §1158 in the first paragraph in the first line (page 1, line 22 in L.D.) by inserting after the following: "not" the following: 'promote,'
17 18 19	Amend the bill in section 1 in §1159 in subsection 1 in the 2nd line (page 2, line 5 in L.D.) by striking out the following: "advertising or conducting or is about to" and inserting the following: 'promoting, advertising or conducting or is preparing to promote,'
20 21 22	Amend the bill in section 1 in §1159 in subsection 2 in the 3rd line (page 2, line 12 in L.D.) by striking out the following: "any person in interest" and inserting the following: 'the recording group'
23 24 25	Amend the bill in section 1 in §1160 in the first paragraph in the 2nd and 3rd lines (page 2, lines 17 and 18 in L.D.) by striking out the following: " $$5,000$ nor more than $$15,000$ " and inserting the following: ' $$500$ '

28	This chapter does not apply to any nonprofit corporation incorporated under the laws

SUMMARY

This amendment makes the following changes to the bill:

It prohibits a person to promote, in addition to advertise or conduct, a live musical
performance or production through the use of a false, deceptive or misleading affiliation
with a performing group and a recording group;

6 2. It clarifies that the court may order restitution only for the recording group;

7 3. It exempts nonprofit corporations from liability under this chapter; and

8 4. It reduces the minimum fine from \$5,000 to \$500 for each violation and removes9 the maximum fine.
