SUMMARY

2 This amendment strikes the requirement in the bill regarding changes to the 3 composition of the State Board of Education related to broad representation of 4 municipalities of varying sizes, but retains the requirement that the composition of the 5 State Board of Education must be broadly representative of the geographic regions of the 6 The amendment also clarifies that the residency requirement for members State. 7 appointed to the State Board of Education is limited to their residency at the time of their 8 appointment. The amendment further provides that the members serving on the State 9 Board of Education at the time of the effective date of this Act continue to serve for the 10 remainder of the terms for which they were appointed and, after the expiration of those terms, that the appointment of State Board of Education members must be made 11 consistent with the provisions of this Act. 12
