 purposes of this subsection, "resident disabled veteran" means a person who:

5 A. Is a resident as defined in section 10001, subsection 53;

B. Is a veteran as defined in Title 37-B, section 505, subsection 2, paragraph A,
subparagraph (3). For purposes of this subsection, "veteran" means a person who
served in the military or naval forces of the United States who was not dishonorably
discharged and entered the service from this State or resided in this State for 5 years
immediately preceding application under this subsection; and

- 11 C. Has a service-connected disability evaluated at: <u>50% or more.</u>
- 12 (1) One hundred percent; or

13 (2) Seventy percent or more as a result of honorable military service and who
 has served in a combat zone during any armed conflict in which participants were
 15 exposed to war risk hazards as defined in 42 United States Code, Section 1711
 16 (b).

Each application must be accompanied by satisfactory evidence that the applicant meets the requirements of this subsection. A permit or license issued under this subsection remains valid for the life of the permit or license holder, as long as the permit or license holder continues to satisfy the residency requirement in section 10001, subsection 53 and the permit or license is not revoked or suspended.

An appropriation from the General Fund in addition to any appropriation made pursuant to the Constitution of Maine, Article IX, Section 22 must be made annually to the department in an amount equal to the revenue lost annually as a result of the department's providing complementary licenses and permits under this subsection instead of having each license and permit purchased individually at the regular fee. The department must deposit any appropriation pursuant to this subsection in the Search and Rescue Fund established in section 10261.

#### **SUMMARY**

18 This amendment changes the title of the bill and replaces the provision of the bill proposing to provide discounted license fees for certain veterans with language that 19 increases the number of disabled veterans that are eligible to receive complimentary 20 lifetime licenses and permits to hunt, fish, trap and guide by reducing the level of 21 disability from 100% for noncombat military and 70% for combat-related disability to 22 23 50% or more disability for all veterans. It also clarifies the definition of "veteran" and how the loss of revenues to the Department of Inland Fisheries and Wildlife for providing 24 these complimentary licenses to be reimbursed from the General Fund. It changes the 25 allocation of the laws establishing the Search and Rescue Fund in order to avoid creating 26 27 a conflict. It also adds an appropriations and allocations section to the bill.

#### **Fiscal Detail and Notes**

Certain changes in the eligibility requirements for complimentary hunting and fishing licenses that are issued to disabled veterans will result in the loss of General Fund revenue collected by the Department of Inland Fisheries and Wildlife. Beginning in fiscal year 2007-08, the estimated annual revenue loss will be \$189,013. The bill also requires the General Fund to annually pay the Search and Rescue Fund an amount equal to the revenue loss from all complementary licenses and permits, including the new ones authorized in this bill. The revenue loss from these complementary licenses and permits is to the General Fund and not to any dedicated account in the department. The bill includes a General Fund appropriation of \$673,663 beginning in fiscal year 2007-08 for this cost and requires that it be in addition to the appropriations the department receives each year that are constitutionally required to be at least equal to the revenues collected. Appropriations in the 2008-2009 biennium are already budgeted in excess of the budgeted revenues.

The bill also includes Other Special Revenue Funds allocations of the same amount to allow spending from the Search and Rescue Fund.
