#### Fiscal Detail and Notes

Exempting from the state income tax certain military retirement benefits will reduce General Fund revenue by an estimated \$12,275,964 in fiscal year 2007-08 and \$9,380,518 in fiscal year 2008-09. This bill also includes a one-time General Fund appropriation of \$11,000 in fiscal year 2007-08 for Maine Revenue Services' related computer programming costs.
