Amend the bill in section 1 in §125 by striking out all of subsection 2

2 Amend the bill by striking out all of section 2 and inserting the following:

3 'Sec. 2. Funding. The Legislature may provide funds to the Department of 4 Economic and Community Development to provide support to the State's 16 counties 5 subject to a 1:1 match.'

SUMMARY

This amendment requires any bonds or salary expenses to be approved by a majority of the county budget committee, whether advisory or not. It also requires a 50% turnout by the voters for a bond approval, as is the current law, rather than changing it to 40% as in the bill. It also strikes out the appropriations and allocations section of the bill, but maintains the possibility of funding in the future. It also allows counties to raise, appropriate, borrow and expend money for county economic and community development.
