1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 8 MRSA §374, sub-§5**, as amended by PL 2003, c. 516, §1 and affected
3 by c. 614, §9, is repealed.

4 **Sec. 2. 8 MRSA §387, sub-§1**, as amended by PL 2003, c. 414, Pt. B, §18 and
5 affected c. 614, §9, is repealed.

6 **Sec. 3. 8 MRSA §387, sub-§1-A** is enacted to read:

7 **1-A. Appropriation.** The money in the State Lottery Fund may be appropriated
8 only for the payment of prizes to the holders of winning lottery tickets or shares and the
9 expenses of the division in its operation of the lottery, and the remainder is evenly
10 divided among the following:

11 A. The Maine Outdoor Heritage Fund pursuant to Title 12, section 10302;

12 B. The Maine Technology Capacity Fund established pursuant to Title 5, section
13 15303-A;

14 C. Jobs for Maine's Graduates established by Title 20-A, chapter 226;

15 D. The Maine Development Foundation as created by Title 10, chapter 107;

16 E. The University of Maine System Scholarship Fund pursuant to Title 20-A, section
17 10909;

18 F. The Maine Community College System, to be applied by the board of trustees to
19 fund its scholarships program pursuant to Title 20-A, section 12716, subsection 1;

20 G. The search and rescue operations as described by Title 12, section 10105;

21 H. The Land for Maine's Future Fund as created by Title 5, section 6203;

22 I. The ATV Recreational Management Fund established by Title 12, section 1893;

23 J. The Housing Opportunities for Maine Program established by Title 30-A, section
24 4852;

25 K. The Agricultural Fair Support Fund established in Title 7, section 91;

26 L. The fund to supplement harness racing purses established in Title 8, section 298;

27 M. The fish hatchery maintenance fund established by Title 12, section 10252;

28 N. The Scholarships for Maine Fund as administered by the Finance Authority of
29 Maine pursuant to Title 20-A, section 11651;

30 O. Maine Public Broadcasting Network;

31 P. Maine & Company;

32 Q. Maine Centers for Women, Work, and Community;

33 R. The Maine Economic Development Venture Capital Revolving Investment
34 Program Fund as administered by the Finance Authority of Maine as provided by
35 Title 10, section 1026-N;
