l	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 29-A MRSA §1411 is enacted to read:
3	§1411. Prohibition against participation in a national identification card system
4 5 6 7	The State may not participate in a national identification card system and the Secretary of State may not amend the procedures for applying for a driver's license or nondriver identification card under this chapter in a manner designed to conform to a national identification card system.
8	SUMMARY
9	The bill prohibits the State from participating in a national identification card system.
